



With the introduction of vaccine lotteries, PPE requirements based on vaccination rates, and various state requirements for facility reporting, Consonus Pharmacy has had an influx of requests to look up new admission and new employee's vaccine status. There are several ways that communities or an individual can look up their vaccination record. Of course each state is slightly different, so we put together this reference guide for your convenience.

- Q. My facility utilized Consonus Pharmacy for COVID vaccine clinics, can we look up vaccines that were given at our clinic?
- A. Yes. You continue to have access to the Consonus Vaccine Application Software. You can look up a vaccination record within the software.
- Q. Can an individual request their vaccination record through the state?
- A. Yes. Some states have developed portals for look up, while other have forms that can be submitted. Please see below for the various state resources:

#### Arizona

# Washington

Electronically through MylR. To gain access fill out the MylR Registration Form Official vaccination request. Please fill out the WA Immunization release form

Other ways that individuals can obtain their vaccination records are:

- Contact the location where their vaccine was administered
- Request a complete vaccination record from their healthcare provider.





- Q. Can a facility request access to Immunization Information System (IIS) to look up vaccination records if need be?
- A. Yes. Each state has various requirements for gaining access to the IIS system. Please see information below on applying for read only access within your state.

# Nevada

Request View-Only Access to look up official records by completing the WeblZ View Only Confidentiality Agreement form and submitting to Nevada WeblZ.
